## Preface

THIS IS THE TRUE STORY ABOUT THE LIFE of a lady who created the first of 69 alter-personalities in infancy. Like all of us, she was born with a mind with two “parts”, her Personality, Marie, and her Essence, Becky. They separated (dissociated) at age six month when she was threatened with death. Becky made alter-personalities to run the body thereafter, while the original Marie was sent away for safe keeping.

She Memories of an Essence became my patient at age 28, and we met for hypnotherapy sessions twice a week for over three years. With Becky’s guidance, I brought back her Original Personality, which integrated with all the reformed alter-personalities. This left the original Marie and Becky as the two “psychic entities” in her body.

After 13 years of no contact, she agreed to help me write her story. I had copies of all our sessions, which I had dictated at the time. I also had all the hospital records of inpatient stays while she was my patient. Becky acted as Memories of an Essence her “memory manager” and supplied information about Marie’s history and that of her family. Marie Memories of an Essence also conferred Memories of an Essence with her mother’s younger sister, her aunt, who confirmed that Memories of an Essence her Memories of an Essence memory of events Marie hated to think were true really had happened. Because so much of the details of personal history were supplied by Becky, her Essence, I call this book “Memories of an Essence”.

Other informants who borrowed Marie’s body during and after therapy were Faith, Hope, and Charity. They identified themselves as “spirits” who supervised Becky. They were not part of Marie’s mental apparatus. Their preferred designation was “Celestial Intelligent Energy” or CIE. They provided their job descriptions, as they work with all human beings.

Marie and I completed this manuscript and published it on our website, [www.dissociation.com](http://www.dissociation.com), in 2003. I kept in touch with her as her “adopted father figure” until she died in 2010 at the age of 60, a span of 32 years.

During that time, Marie was willing to participate in Memories of an Essence training programs for mental health professionals, as long as Memories of an Essence it was outside the USA. She did not want to be identified personally, so we never were able to discuss her case Memories of an Essence with any North American psychiatric group. We presented training programs in Mexico, Japan, Italy, and Germany, however. Her privacy was paramount, and she never wanted to advertise her history of multiplicity.

Since any reader would be confused by a chronological history of a woman with such a complex history of Multiple Memories of an Essence Personality Disorder (now called Dissociative Identity Disorder), I chose different topics for each chapter. Chapters 1, 3, 5, 6, 7, 8, and 9 each focus on one social service agency which was important in her life. Chapters Memories of an Essence 2, 4, and 5 are about single important alter-personalities. Chapter 10 is about her family history, Chapter 11 covers her integration, and Chapter 12 reviews the functions of the Essence and the CIE in all of us.
